Anti-Fraud Agency & Victim Funds Recovery Contract

This Non-Disclosure Agreement ("Agreement") is governed by the International Anti-Fraud Alliance

The purpose is to prevent unauthorized disclosure of confidential information. Protection of **Anti-Fraud Agency** & Victimized Client Information

1. Definition of Anti-Fraud Agency Services.

Based on information provided by the victim, Anti-Fraud Agency uses a team of professional hackers and advanced block-chain tracking methods to help victimized users deal with the recovery of their money

(While Anti-Fraud Agency is helping the victim to recover funds, the victim must maintain confidentiality)

2. Victims' obligations.

Victims must be patient and cooperate with Anti-Fraud Agency in tracing the case and reasonably complete any strategy proposed by the processor.

In order for funds to be recovered successfully. The victim must not unreasonably interfere with the process of tracing the funds.

3. Time frame.

Because each victim's case and the amount of money lost varies, the time frame for tracing funds will also vary. Therefore, victims must cooperate with the conditions required for the progress provided by Anti-Fraud Agency. Only then can the lost funds be successfully recovered. (Careful and strict cooperation with Anti-Fraud Agency's investigation needs conditions, can be faster to recover the funds)

4. Service Fee.

This agreement expresses the full understanding of both parties regarding the subject matter, the fees are determined by the amount of the trace and the difficulty of the case, all recovered funds and service fees will be received and sent in the form of cryptocurrency (As Anti-Fraud Alliance approach to recovering funds is to use advanced block-chain technology and a team of hackers and can only be solved in the crypto domain, the service fee will be divided between the Anti-Fraud Agency team to develop more specialized technology for recovering funds and the charity to invest in it)

5. Waiver.

In the event that a victim user fails to cooperate in the recovery of funds in accordance with the terms and conditions required by Anti-Fraud Agency

(The funds recovered by Anti-Fraud Agency will be donated to charity for decentralized destruction)

6.Additional Provisions.

The confidentiality provisions of this Agreement shall survive termination of this Agreement and the recipient's obligation to keep confidential information confidential shall survive until the confidential information no longer qualifies as a trade secret or until the disclosing party sends written notice to the recipient to release the recipient from this Agreement, whichever occurs first. By accessing the Services. You agree that Anti-Fraud Agency has the right to investigate any violation of these Terms, to determine unilaterally whether you have violated these Terms, and to take action in accordance with the relevant provisions without your consent or prior notice. Examples of such actions include, but are not limited to blocking and closing order requests.

(where necessary for the victim to cooperate as reasonably required by Anti-Fraud Agency progress in recovering the amount each time)
